

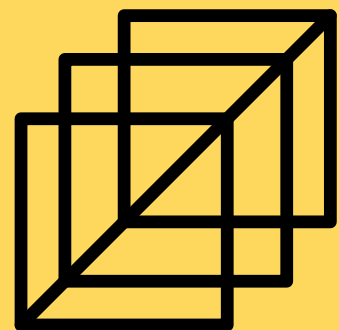

Interreg V-A Greece-Italy Programme

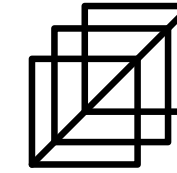

Capitalisation

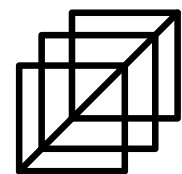
During 2022 the programme was selected by Interact for the Interact “Capitalisation tailored support 2022” together with other 6 programmes.

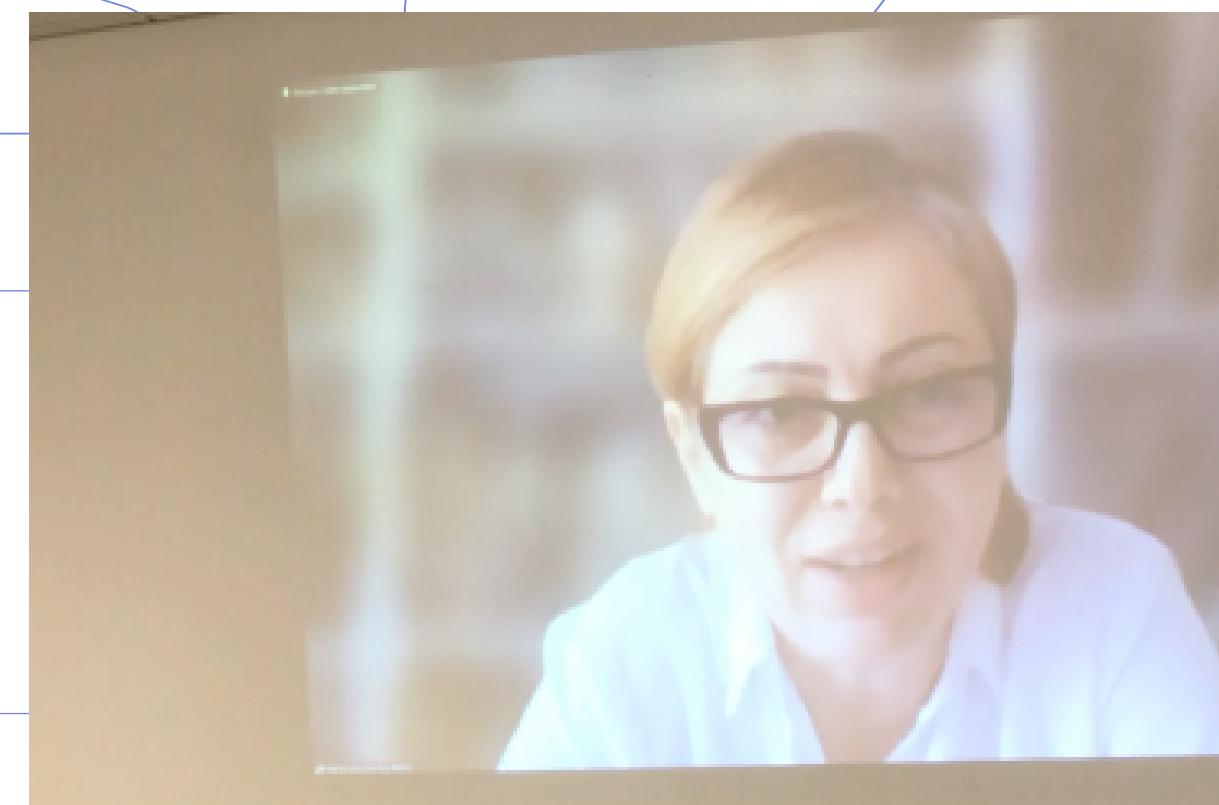

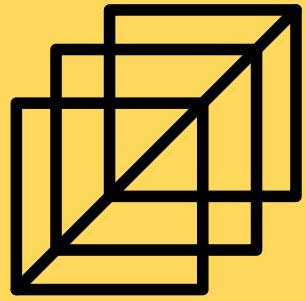
Capitalisation Event 19 October 2022

More than 150 participants, in person and online, took part in the capitalisation workshop, organised by the Interreg Greece-Italy Programme at Fiera del Levante on 19 October 2022.
