Amendment of Joint Decision No. 300539/YΔ 1605/14-04-2016 (Official Gazette 1453/v.B'/24-05-2016) of Ministers of Finance, Development and Tourism and the Deputy Minister of Interior and Administrative Reconstruction entitled «Establishment and staffing of Joint Secretariats within the framework of the Cross-Border and Transnational Cooperation of the «European Territorial Cooperation» Objective according to Art. 41 of Law 4314/2014, as applicable» (Official Gazette 1453/v.B'/24-5-2016), as amended by the Joint Decisions No. 302081/YΔ4193 03-11-2017 (Official Gazette 3986/v.B'/15-11-2017) and No. 301870/YΔ4798/4-10-2018 (Official Gazette 4727/v.B'/22-10-2018) of the Ministers of Finance, Development and Administrative Reconstruction.

THE MINISTERS OF FINANCE AND DEVELOPMENT – ADMINISTRATIVE RECONSTRUCTION

Having regard to:

- 16. The cross-border and transnational cooperation programmes of the «European Territorial Cooperation» objective of the Programming Period 2014-2020, for which the management competence lies to the Special Management Service of the Operational Programmes under the Objective «European Territorial Cooperation» of the Ministry of Finance, Development and Tourism: i) INTERREG V-A Greece Cyprus 2014-2020, ii) INTERREG V-A Greece-Bulgaria 2014-2020, iii) INTERREG V-A Greece-Italy, iv) IPA Cross-border cooperation programme Greece Former Yugoslav Republic of Macedonia 2014-2020, v) Interreg IPA CBC Greece Albania 2014-2020 and vi) INTERREG V-A Balkan-Med 2014-2020.
- 17. Art. 3 of Law 2372/1996 about the Articles of Association of the Management Organisation Unit of Development Programmes, as amended and applicable.
- 18. Law 4251/2014 (Official Gazette 80/v.A'/01-04-2014) «Entry, stay and social integration of third country nationals on the Greek territory» as amended and applicable.
- 19. The need to clarify the staffing process of the new positions in the Joint Secretariats of the Cooperation Programmes of the Programming Period 2014-2020, in line with Art. 9, par. 9 of the Joint Ministerial Decision No. 300539/ΥΔ 1605/14-04-2016 (Β' 1453), as applicable.
- 20. The fact that this decision entails no expenditure, we decide:

Article 1

Under Art. 4, entitled «Staffing and personnel of Joint Secretariats of the Cross-border and Transnational Cooperation», par. 3 is modified as follows:

«The filling of new positions and any vacancies that may arise in the Joint Secretariats of the Programmes under Par. 2 after the completion of the above process, and the initial staffing of the Joint Secretariat of the Programme of Cross-border Cooperation «Balkan-Med» will be done through an Open Call addressed to:

- a) Personnel at the Management Organisation Unit of Development Programmes (MOD SA)
- b) Executives of the public sector, the broader public sector and private sector from Greece and abroad.

The formal, substantive and additional qualifications per position including the position of the Coordinator, are described in the tender call.

Article 2

Under Art. 6, entitled «Selection process», par. 4 is modified as follows:

«Should any vacancies arise or new job positions are created, according to Art. 3, par. 9 herein, during the Programming Period, it is possible to invite the next candidate from the shortlist of candidates. If the shortlist of candidates has not been exhausted, it is possible to repeat the process described in the previous articles.

Otherwise, the Joint Decision No. $300539/Y\Delta$ 1605/14-4-2016 (Official Gazette 1453/v.B'/24-05-2016) of the Ministers of Finance, Development and Tourism and the Deputy Minister of Interior and Administrative Reconstruction entitled «Establishment and staffing of the Joint Secretariats within the framework of the Cross-Border and Transnational Cooperation Programmes of the «European Territorial Cooperation» Objective, according to Art. 41 of Law 4314/2014, as applicable» (Official Gazette 1453/v.B'/24-5-2016), as amended by the Joint Decision No. $302081/Y\Delta4193/03-11-2017$ of the Ministers of Finance and Development and Administrative Reconstruction.

The present shall enter into force upon its publication.

This decision shall be published on the Official Gazette.
